XTO Permian Operating LLC has applied to the New Mexico Oil Conservation Division for a permit to dispose of produced water into a porous formation not productive of oil or gas.

The applicant proposes to dispose of produced water into the **Poker Lake Unit 21 Lincoln Fee SWD #1** (Siluro-Devonian and Fusselman Formations). The maximum injection pressure will be 3,274 psi and the maximum rate will be 40,000 bbls. produced water per day. The proposed disposal well is located approximately 14 miles Southeast of Malaga, New Mexico in Section 21, T25S, R30E, 370' FSL & 1355' FEL, Eddy County, New Mexico. The produced water will be disposed at a subsurface depth of 16,368'-17,683'.

Notice is being republished due to a change in the disposal interval.
