
Director:


As owner-operator of the above listed well, I am requesting an extension of time to drill and complete the Ojo Chiso #2. Our permit runs out in February 2020 which only leaves us about two and a half months to convert.

We have been trying to secure a drilling rig to complete the conversion, only to be cancelled. Our latest is "we will get a rig in three to four months". We have been out some major expenses, permitting, surveying and location work, and do not want to lose this permit. An extension of one year would be appreciated.

My consultant has reviewed the AOR for this permit and no new wells have been completed, and all the offset operators are the same.
