Spur Energy Partners LLC respectfully requests administrative approval of a non-standard location on the Lakewood Federal Com 15H, API Number 30-015-46064, Property Code 325865. The 15H well is proposed to be completed in the N. Seven Rivers; Glorieta-Yeso pool, Pool Code 97565. The proposed wellbore is to be completed within 330’ feet of the E/2 of the W/2 of Section 34. The proposed interval is projected as follows:

Surface Hole – 520’ FNL 1270’ FWL Lot 4 Sec 3 T20S R25E
First Take Point – 100’ FSL 1205’ FWL Unit M Sec 34 T19S R25E
Last Take Point – 100’ FNL 1205’ FWL Unit D Sec 34 T19S R25E
Bottom Hole – 20’ FNL 1205’ FWL Unit D Sec 34 T19S R25E

The adjoining units which the unorthodox location encroaches are located in T19S R25E, Section 34, Units C, F, K and N.




