The State Land Office protests the SWD application of Longfellow Energy Partners, LP, Angus 17 Federal SWD #1, located 605 FSL and 705 FEL, Unit P-17-17S-29E, which we received on August 17, 2020. The State Land Office protests the intended location of this well due to its proximity to state trust lands. The proposed SWD is located less than 1/4 mile from A-20-17S-29E (605 feet). The acreage in Section 20 is State Land Office surface and subsurface estate.
