OCD staff have completed the administrative review for the Anthem - OXY POGO State #1 SWD #1 (pBL2017436876) application.

Note: the OCD is currently a party to pending cases involving both commercial and noncommercial injection into the DMG. Therefore, decisions around DMG applications are still undecided.

The original well completion and subsequent P&A will be considered during the technical review process. Until the technical review does occur, no further information is needed from the applicant.

Records indicate that the application was indeed submitted on June 18, 2020 and that notice was carried out properly. OCD UIC staff attempts to, but does not always review applications in the order they were received. As it stands, there are 179 pending C-108 applications that were submitted before the Anthem Application. Staff appreciates continued patience as it works through the backlog.

I'd like to follow up on Anthem's C-108 application pBL2017436876 to get an understanding on where the application is at in the review process. In this application, Anthem proposes to recomplete an existing wellbore (30-015-34549) as a Bell Canyon/Cherry Canyon disposal well. 30-015-34549 was originally drilled and completed by OXY in 2006 and was subsequently P&A'd and released by OCD in 2008.

The application was received by OCD on June 18, 2020, is not protested, and has been in the administrative review queue for almost 8 months. This wellbore is on private surface and State minerals. Notification of the application was sent to all Affected parties including the surface owner, mineral owner (SLO), and surrounding operators and none of these Affected Parties have protested or otherwise opposed the application.
