I. This recently drilled Winchester; Bone Spring (65010) oil well is on NM State Land Office (NMSLO) surface and 640-acre NMSLO oil and gas lease E0-5073-0007 (Exhibit A). Dedication is the 160 acres (Exhibit B) comprising the S2N2 25-19s-28e. Some take points are too far south. The south most take point is 258' from the closest perpendicular dedication boundary (Exhibit B). This is towards the interior of the same Colgate operated lease, but the N2S2 Section 25 has different working interests.

Colgate requests approval of a nonstandard location due to drilling difficulties and in the interest of maximizing recovery of reserves. The well was drilled as much as 72' south and outside of the standard 330' perpendicular setback.

Colgate initially achieved the build and turn rates required in the horizontal drilling plan. However, the formation encountered at $\approx 8380'$ TVD caused the motor to yield significantly less than Colgate had anticipated based on motor specifications at 100% slide. Focus was simultaneously placed on building and turning to avoid landing low and too far right of the centerline. When it was observed that the motor yields were not sufficient, the rig tripped out of the hole to replace the original motor with a larger bend motor in order to improve build and turn rates. At the point Colgate was able to land the wellbore, Colgate was a maximum of 85' right of centerline.

A standard location must be at least 330' from the perpendicular dedication boundary. The south most take point is 258' from the south dedication boundary (see C-102 as EXHIBIT B). The take point is 72' too far south.

II. Form C-102 showing the well and its 160-acre dedication (S2N2 Section 25) is attached as EXHIBIT B. Bone Spring dedications and Bone Spring operators are shown on Exhibit C.

III. Oil and gas leases are shown on EXHIBIT D. Encroachment to the south is toward the interior (N2S2 Section 25) of the same NMSLO lease. The N2S2 Section 25 Bone Spring dedication is operated by Colgate (30-015-46354 & 30-015-46357), but has different working interests than the S2N2 Section 25.

IV. See Exhibit C for Bone Spring dedications. If Colgate does not receive approval for the NSL portion of this well bore, then it would be forced to squeeze the NSL portion of the well bore and leave adjacent acreage undeveloped.

V. Constraints include the previously described down hole difficulties.

VI. Archaeology is not an issue.

VII. I hereby certify that Colgate Operating LLC and its partners have 100% of the Bone Spring working interest in the lease which comprises the two relevant 160-acre spacing units (S2SN2 & N2S2 Section 25). Working interests vary between the two dedications. This information is current and correct.
