Dear Dylan,

On behalf of BAM Permian Operating, LLC, I am requesting a 90-day extension of SWD-2381 approval for their Linley State SWD 1 (30-005-64358; M-32-15s-29e). The SWD approval is currently due to expire July 16, 2021. Disposal will be from 3750' to 4060' in the San Andres and Glorieta.

Due to Covid-19 and last year's widely fluctuating oil prices, BAM had postponed drilling of the Linley State SWD 1 and its adjacent Linley State 1H (30-005-64337; M-32-15s-29e) oil well. BAM now plans to spud Linley State SWD 1 in May 2021. Once that well is completed, BAM will drill and complete the Linley State 1H on the same pad.

This combined dual well effort will take 45-60 days and bring BAM very close to the SWD-2381 expiration date of commencing injection operations by July 16.

BAM Permian Operating, LLC therefore requests a 90-day extension of the expiration date to October 16, 2021. There has been only one substantive well change within a 1/2-mile radius since the original C-108 application. That change is APD approval for BAM's Linley State 1H. See attached page for a list of all existing or approved wells within a 1-mile radius.


