The original application states that the surface location of the Armadillo 362528 State SWD 1 would be 2538 feet from the North line and 386 from the East line, in Section 36, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico. The amended location will be 1654 feet from the South line and 250 feet from the East line, in Section 36, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico. There are no other changes to the original application.

Enclosed is an amended for C-102 showing the correct footage call for the surface location along with the correct maps required for the C-108. This amendment is being made to satisfy concerns by EOG Resources, Inc. "EOG". Their concerns have been addressed and EOG Resources, Inc. "EOG" has agreed to waived objections to this well given this change of location.
