This oil commingle is part of a daisy chain for facility work for a new development. Would it be possible to get it reviewed sometime this week or early next week?

Cedar Canyon 16-1 wells are part of PLC 580B, but they previously had a separate sales point from the rest of the Whomping Willow wells. This amendment will send the CC 16-1 wells to the Whomping Willow oil sales point, and remove the previous separate CC 16-1 oil sales point.

The gas commingle is part of PLC 750A. In the original submittal for the gas commingle, Whomping Willow and Cedar Canyon 16-1 gas were combined into one sales point, so that PLC does not need to be updated.
