Reference is made to your application received on August 25<sup>th</sup>, 2022.

This vertical well was drilled at an unorthodox oil well location described above in the referenced pool or formation. This location is governed by statewide rules, which provides for 40-acre units, with wells to be located at least 330 from the QTR/QTR line.

This well's completed interval is as close as 200 feet to the western boundary. Encroachment will impact the following tracts.

Section 5, encroachment to the SW/4 SE/4

The Division understands you have given notice of this application to all operators or owners who are "affected persons," as defined in Paragraph (8) Subsection A of 19.15.2.7 NMAC, in all adjoining units towards which the proposed location encroaches.

Division understands that you are seeking this orthodox location due to recompleting this well into a different pool/formation within the Wolfcamp formation underlying the SE/4 SE/4 of Section 5.
