I hope that you are both doing well! Marathon Oil Permian LLC received the attached NSL applications filed by Cimarex for the following wells:

Riverbend 12-13 Fed. Com 1H
Riverbend 12-13 Fed. Com 2H
Riverbend 12-13 Fed. Com 19H
Riverbend 12-13 Fed. Com 20H

These wells appear to be located within the E/2 of Sections 12 and 13, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico. Marathon objects to these applications and submits this protest. The proposed FTP for Cimarex's wells will encroach upon Marathon's interests and operated spacing unit in the E/2 of Section 1 and drain production from Section 1. This impacts Marathon's correlative rights. Also, it appears that Cimarex's SHL is off-lease and that Cimarex's proposed wells may traverse across Marathon's operated spacing unit. Marathon is concerned that the traversing portions of the laterals for the proposed wellbores may interfere with Marathon's development in Section 1. As a result, Marathon opposes the granting of Cimarex's applications.

Pursuant to Division rules 19.15.16.15(C)(6) and 19.15.15.13 NMAC, Cimarex Energy Co. (OGRID 215099) seeks administrative approval of an unorthodox well location ("NSL") for its Riverbend 12-13 Federal Com 20H well (API No. 30-015-49536) (the "Well"). The Well will be located in a 640-acre, more or less, spacing unit underlying the E/2 of Sections 12 and 13, Township 25 South, Range 28 East, NMPM, Eddy County, New Mexico, and will be in the Purple Sage Wolfcamp Gas Pool (Pool ID: 98220). A C-102 for the Well is attached as Exhibit A.

The Purple Sage Wolfcamp Gas Pool has special pool rules which establish 320-acre building blocks and 330' foot setback requirements. The Well will be in the E/2 of Sections 12 and 13, *i.e.*, 320-acre building blocks, but will have setbacks of 100' for the toe and heel, which requires an NSL approval. As shown on Exhibit A, this is a horizontal well that will be drilled as follows:

- Surface Hole Location: 1207' from the South line and 2422' from the West line of Section 1 (outside of the horizontal spacing unit);
- First Take Point: 100' from the North line and 2310' from the East line of Section 12;

- Last Take Point/Bottom Hole Location: 100' from the South line and 2310' from the East line of Section 13.

Cimarex has included as Exhibit B a letter explaining why this application is needed. Cimarex also provides a map of the area, attached as Exhibit C, which shows the tracts upon which the unorthodox location will encroach.

As discussed above, the first and last take points for the Well are closer than 330' from the boundary of the spacing unit. Specifically, the first take point would be 100' from the North line of Section 12 and the last take point would be 100' from the South line of Section 13. *See* Exhibit A (C-102). The unorthodox location will encroach towards the SE/4 of Section 1 of Township 25 South, Range 28 East and the NE/4 of Section 24, Township 25 South, Range 28 East. Cimarex has confirmed that the tracts adjoining the spacing unit by a corner are more the 330' away from the unorthodox locations requested.

Pursuant to Rule 19.15.4.12(A)(2) and Rule 19.15.2.7(A)(3), Cimarex is providing notice to the operator of the SE/4 of Section 1 of Township 25 South, Range 28 East (Marathon Oil Permian LLC) and to the operator of the NE/4 of Section 24, Township 25 South, Range 28 East (Mewbourne Oil Co.). Cimarex is also providing notice to the Bureau of Land Management. Proof of mailing, along with a copy of the notice letter sent to affected parties, is attached hereto as Exhibit D.
