Mr. de la Cruz,

NMOCD is in receipt of the form C-141 submitted for a release of produced fluids, discovered 6/13/2011, at the Southern California 14 Fed 1 (30-015-04600). Please proceed with the investigation/delineation of the site. Provide NMOCD copies of any and all analytical data obtained from the site, and a proposal for remediation of the site.

Be advised of reporting requirements, to NMOCD, for produced fluid releases in the state of New Mexico. Any fluid release over 25 barrels requires "immediate" verbal notification. Immediate, by rule, is within 24 hours of discovery. This notification is to be followed up by submittal of the form C-141 within 15 days of discovery. A release in volume greater than 5 barrels, but less than 25 barrels, requires submittal of the C-141 within 15 days of discovery (immediate notification not required). Reporting to NMOCD is required regardless of surface or mineral ownership, and is the responsibility of the operator of record. All produced fluid releases (including less than 5 barrels) require remediation by the responsible party/operator of record. Reporting requirements by any other regulatory authority is in addition to NMOCD requirements, and is the responsibility of the operator.

NMOCD currently shows Tom R Cone (OGRID # 188152) as operator of record for this well.
