A pressure gauge on the tubing broke. The well was shut in, vacuum truck and roustabout crew was called to the location.

Based on the amount of fluid released, all oil recovered, impacted soil was scrapped immediately and hauled off to NMOCD approved site, and fluid did not leave location Yates Petroleum Corporation requests closure.**
