During the trenching for a new flowline, hydrocarbon impacted soils were discovered. Upon excavation of the impacted soils, water seeped into the excavation.

Describe Area Affected and Cleanup Action Taken.*
Impacted soils were excavated to an approximate size of 30' x 45' x 9' deep. A soil sample from the SW corner of the excavation was collected (attached). Another composite sample was collected from the 4 walls and will be submitted to the OCD when available. The soils were hauled to commercial disposal. The excavation was backfilled w/ clean soils. A water sample will be collected and the results will be submitted to the OCD.
