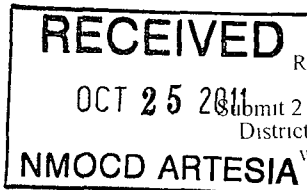




**Describe Cause of Problem and Remedial Action Taken.** Additional tanks were added to this lease with a new load line to the east. The (old) south load line is still in place but is not used by crude drivers due to it being next to the load line for produced water and causes trucks to wait. Crude driver pulled to east load line and began loading. Driver noticed crude oil running down the fence line behind him. He ran over to the south line and discovered it to be open. He then shut the valve. It is unknown how or why the south valve was open. We have contacted Mewbourne Oil and requested that the south valve be removed or locked so that it cannot be opened.

**Describe Area Affected and Cleanup Action Taken.** Area approximately 100 x 40' on a caliche packed well location. Madrin services was contacted and the affected soil removed. Soil samples were taken and sent to Cardinal Laboratories in Hobbs, NM for testing prior to filling in. Test results returned high chloride levels. Per Mike Bratcher additional samples will be taken approximately 8' deeper. Results pending.
