The operator shall notify the Hobbs District Office of the Division upon implementation of the commingling process. It is the responsibility of the producer to notify the transporter of this commingling authority.

Administrative permits PLC-54 and PLC-54-A are hereby superseded and no longer in effect.

This surface commingling is dependent upon like approval from the New Mexico State Land Office.
