

We are writing to request your administrative approvals to install and operate the captioned gathering system and central delivery gas sales meter for three wells, all operated by Dugan Production Corp. and completed in either the Flora Vista Fruitland Sand gas pool (76600) or the Basin Fruitland Coal gas pool (71629). All three wells are located in the E/2 of Section 2, T-30N, R-13W and the spacing units include five state leases, three held by Dugan Production (E-453-18, E-3555-7 and OG-4070-1) and two held by Burlington Resources Oil & Gas (E-4550-6 and OG-959-6). The interest ownership is identical for two of the wells (Moncrief Com 100 & 101) but is different for the Seven of Diamonds No. 2. The CDP gas sales meter is on lease for one well (Seven of Diamonds No. 2), but is off lease for two wells (Moncrief Com 100 & 101).

NMOCD Form 107-B is attached in support of this application. **Attachment No. 1** presents a facility diagram and well information for the three wells that will be connected to the Seven of Diamonds CDP. **Attachment No. 2** presents a map showing the wells along with the leasehold interest in the E/2 of Section 2, T-30N, R-13W. This map was reproduced from the Farmington, North Quadrangle USGS topographic map.

We do not anticipate any commingling of oil or condensate since there is no condensate or oil production from the Fruitland Sand or Fruitland Coal completions.

Attachment No. 3 presents a summary of the interest owners in the wells to be connected to the Seven of Diamonds CDP. All interest owners in these wells are receiving a complete copy of this application. **Attachment No. 5** includes a copy of the notice letter sent to the interest owners. All letters were sent by certified, return receipt mail and upon receiving the receipts, copies will be forward to the NMOCD. Also included in Attachment No. 5 is a copy of our advertisement placed in the legal ads of the Farmington Daily Times on 12/4/11. This ad was placed anticipating that at least one of the 23 interest owners (9 WI and 14 ORRI) will have an address that is not current.

Attachment No. 4 presents the proposed allocation procedures. Each well will be equipped with a conventional continuous recording dry flow gas allocation meter (or some form of approved alternative measurement) operated and maintained by Dugan Production. Prior to converting any gas measurement from a conventional gas meter to an alternative measurement method, we will seek formal approvals.

The charts from each allocation meter will be integrated by a commercial integration service and the volumes recorded will be utilized to determine factors for allocating CDP volumes, BTU's and revenues to the individual wells. The Fruitland Coal wells will be equipped with rod pump equipment and water produced up the tubing and will be moved to the Moncrief No. 100 location by a pipeline gathering system installed and parallel to the pipeline for gas. All water production will be delivered to a conventional separator and any gas recovered from the water at this separator will be metered using a conventional dry flow meter and then delivered to the CDP for sale. Gas recovered at the separator will be allocated between the wells delivering water based upon volumes of water delivered. To date, very little water has been recovered from the Fruitland Sand completion in the Seven of Diamonds No. 2. All water recovered will be stored on location at the Moncrief No. 100 and disposal will be by trucking to one of Dugan Production's water disposal wells or to a commercial water disposal facility depending upon available capacity at Dugan's disposal facilities.



Base Data:

U = Water Volume (BWPD) from Periodic Well Test x days operated during allocation period.

V = Water Volume (bbl) at Central Battery during allocation period.

W = Gas Volume (MCF) from allocation meters at individual wells and central battery separator during allocation period.

X = Gas Volume (MCF) from CDP Sales Meter during allocation period.

Y = BTU's from CDP Sales Meter during allocation period.

Allocation Period is typically a calendar month and will be the same for all wells.

1. Individual Well Gas Production = A + B + C + D + E + F.

A = Allocated Sales Volume, MCF = $(W/SUM W) \times X$

B = On lease fuel usage, MCF. Determined from equipment specification and operating conditions.

C = Purged and/or vented gas from well and/or lease equipment, MCF. Calculated using equipment specifications and pressures.

D = Allocated fuel from gathering system equipment, MCF. The total fuel required to operate gathering system equipment will be allocated to the individual wells benefiting from the equipment using allocation factors determined by W/SUM W for the wells involved.


E = Allocated volume of gas lost and/or vented from the gathering system and/or gathering system equipment, MCF. The total volume will be determined using industry accepted procedures for the conditions existing at the time of the loss. All volumes corresponding to liquid condensation within the gathering system will also be determined. The total volume lost and/or vented will be allocated to the individual wells affected using factors determined by W/SUM W.

F = Allocated gas sales volume (MCF) associated with water production = (A) in mcf for the central battery separator multiplied by a factor of $(U/SUM U)$ for wells delivering gas and water to the central battery separator.

2. Allocated Individual Well BTU's = $((W \times \text{Individual well BTU}) / \text{Sum } (W \times \text{individual well BTU})) \times Y$.

Individual well gas heating values to be determined in accordance with regulations (currently BLM's Onshore Order No. 5).

3. Individual Well Water Production = Allocated production volume, bbl = $(U/\text{Sum } U) \times V$.

Attached for your information and review is a complete copy of Dugan's application to the New Mexico Oil Conservation Division and the New Mexico State Land Office requesting their approvals to install and operate a gathering system and central delivery gas sales meter (CDP) for three wells; Dugan Production's Seven of Diamonds No. 2 plus Moncrief Com No. 100 and No. 101. According to our records, each of you has an interest in one or more of the wells that are proposed to be included. The wells in which you have an interest are listed on the attached address list and also on Attachment No. 3 to our application which also includes your interest ownership. Dugan Production will install, operate and maintain the gathering system and will pay all costs associated with this proposal. You will have no costs associated with this proposal other than a monthly charge based upon volumes produced for operation of the gathering system and water disposal. These fees will be based upon our actual installation and anticipated operating costs. These fees on our other gathering systems range from \$0.27 to \$0.40/mmbtu for gathering, \$0.09 to \$0.15/mmbtu for compression and \$0.70/bbl for water disposal

This matter does not require any action on your part. NMOCD regulations require that all interest owners receive notice of our application. Should you have any questions, need additional information, or have any concern as to our application, please let me know.
