The New Mexico Oil Conservation Division District 2 office (OCD) is in receipt of a remediation plan (plan) proposing methods to be used to remediate impacted soils resulting from a release of produced fluids at, or in the vicinity of, the well site referenced above. The plan, dated January 3, 2012, contains initial analytical data and site ranking criteria. The plan was formulated and presented to OCD by Talon, LPE on behalf of Devon Energy.

The plan is approved with the following conditions/stipulations:

- > Notify OCD District 2 office 48 hours prior to commencement of remedial activities.
- > Notify OCD District 2 office 48 hours prior to obtaining samples where the analyses are to be presented to OCD.
- > Provide OCD confirmation sample data and obtain approval prior to backfilling.
- > Project is to be completed and closure documentation submitted to OCD not later than March 18, 2012.
- > Like approval by any other regulatory authority as may be applicable.

Be advised, OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state, local laws and/or regulations.
