- Notify the OCD District 2 office 48 hours prior to obtaining samples where the analyses will be submitted to the OCD.
- Like approval by BLM or any other regulatory authority as may be applicable.

Please be advised OCD approval does not relieve the operator of liability should their operations have failed to adequately investigate and remediate contamination that may pose a threat to ground water, surface water, human health or the environment. In addition, OCD approval does not relieve the operator of responsibility for compliance with any other federal, state or local laws and/or regulations.

At this time, an RP number has not been assigned to this release. I will advise as soon as that number is available.
