
Yates is ready to commence operations on this re-entry as soon as you can grant this approval.

Dear Rob:

We are in receipt of your request for a waiver to the proposed unorthodox well location referenced above. As you are aware, Manzano owns the leasehold in the E/2 of Section 6, T11S, R35E. We have also acquired the operating rights in the S/2 of Section 34 and the SW/4 of Section 35, T10S, R34E from Featherstone Development Corporation and Olen F. Featherstone II.

Manzano is willing to waive its objection to the proposed unorthodox location subject to the following terms and conditions:

- 1) Yates to provide Manzano with all well information, including all drilling reports, OCD filings, logs, DST's, etc. from its Southern Union ATO State #1.
- ★ 2) Yates will allow, without protest, Manzano to propose a well ^{and one (1) well only} no closer than 330 feet off of any section line bordering Section 6, T11S, R35E or Sections 34 & 35, T10S, R34E. Manzano also agrees to provide Yates all well information on ^{one} ~~any~~ approved unorthodox location~~s~~ not protested.

If this is agreeable, please execute below and return one (1) copy to my attention and I will in turn return your requested waivers.
