Each of these diversely owned wells shall be equipped with continuous metering separators for oil production prior to oil being commingled for sales.

The oil sales point for this commingled production shall be located at the battery near the Ohkay BHH State Well No. 1 in Lot 4 of Section 6, Township 25 South, Range 30 East. Oil from the Wyatt BHT State Well No. 1, the Canyon BJK State Well No. 1Y, and the Canyon BJK State Com Well No. 2H are approved for off lease measurement and sales after being metered on-lease.

Gas commingling from these wells is approved under Division administrative Order No PLC-309.

It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Artesia district office of the Division upon commencement of commingling operations.
