


Describe Cause of Problem and Remedial Action Taken.* A hot oil unit caught fire releasing 35 bbls of oil with 5 bbls recovered.

Describe Area Affected and Cleanup Action Taken.* Approximately 23,940 square feet of area was affected by the release of ± 35-bbls of oil V ± 5-bbls of oil were recovered from the site. An Emergency Response Team arrived at the release area and began continuous abatement of the impacted area. Standing liquid was scraped up, blended and stock piled on location. Impacted material was placed on the contaminated caliche to prevent additional contamination of the area.

Yesterday afternoon around 4:00pm Chesapeake had a hot oil unit catch fire on the Brushy 12 Federal 1, we lost 35 barrels of oil to the ground surface. Most of the fluid stayed on location, however some fluid did run off location on the south side of the well pad into a ravine. Environmental response crew was dispatched and started cleaning up the saturated soils last night and will continue cleanup efforts today. I will follow up with a C-141, if you have any further questions please let me know.
