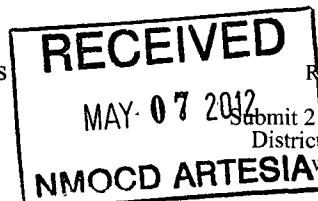

Based on amounts released and lost, elevated salts in background sample taken off of location, and the low porosity clay layer that overlays groundwater, Yates Petroleum Corporation requests closure.</b>
