RKI Exploration & Production, LLC ("RKI") respectfully requests administrative approval of an unorthodox oil well location for its RDX 16 #8 well at the location described above, which is currently permitted in the Brushy Draw, Delaware, East Pool (8090), which requires standard 40-acre spacing with wells located no closer than 330 feet to the outer boundary of the spacing unit.

The RDX 16 #8 was originally planned to be staked at an orthodox location of 1,650' FNL & 2,310' FEL but had to be moved north to its existing location of 1,500' FNL & 2,310' FEL due to topographic issues.

RKI is the operator and sole lessee of all offsetting tracts; therefore notification of this application is not required.

Please find attached a Form C-102 showing the well location and affected offsets along with a topographic plat.


