The well developed a hole in the casing, allowing water flow from injection wells. A clamp has been placed on the casing the well has been turned in for repair.

15 bbls of produced water was released from the hole in the casing and we were able to recover 12 bbls with a vacuum truck. All fluid remained on location and the location has been scraped. Tetra Tech will sample the spill area on the pad to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.
