Glenn, this is an older condensate release site that Enterprise recently investigated to determine if further actions are necessary or not. We cannot find a record of any initial reporting to the OCD regarding the site, and have submitted a C-141 Notification after I talked with Brandon earlier today. Due to the low concentrations of benzene measured in groundwater at this location, a permanent monitor well will be necessary to determine if any impacts are actually present above agency action levels. Based on the information I currently have, the affected area appears to be very limited in extent. We are currently preparing a work plan for investigation of the site to ensure any impacts are fully delineation and remediated. The work plan should be submitted to the OCD within the next week or so. Thanks.
