It is requested that surface commingling of Vacuum;Abo Reef/Vacuum;Blinebry/Vacuum;Bone Spring pools be approved for the following lease: Ohio State V-7048-1 Sec. 7, T18S, R35E

The tank battery is located in the NE/4 SW/4, Sec. 7 T18S R35E. Proper allocation for production will be measured using periodic well tests. Mack Energy has made notification to all parties owning an interest in this lease, including the oil purchaser, of the intent to commingle. Interests in all pools on this lease are common.

Mack Energy is currently producing the Ohio State #1,2,4 in the Blinebry and intend to complete the #5, in the Bone Spring/Abo formation. At this time we are requesting approval to add the Abo Bone Spring to this production.
