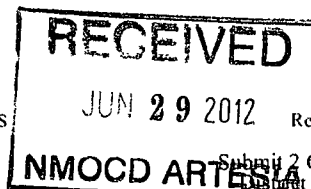


Describe Cause of Problem and Remedial Action Taken.*

The produced water tank at the Chicken Hawk State Tank Battery overflowed due to an electrical problem that did not allow the high level alarm to be sent out. Electricians have been called out to the facility to correct the problem

Describe Area Affected and Cleanup Action Taken.*

Initially roughly 85bbls of produced water was released from the water tank and we were able to recover 80bbls with a vacuum truck. The entire release was completely contained inside the dike walls of the tank battery. The spill area measured approximately 20' x 40'. BBC International Inc. will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOCD for approval prior to any significant remediation work.

I hereby certify that the information given above is true and complete to the best of my knowledge and understand that pursuant to NMOCD rules and regulations all operators are required to report and/or file certain release notifications and perform corrective actions for releases which may endanger public health or the environment.
