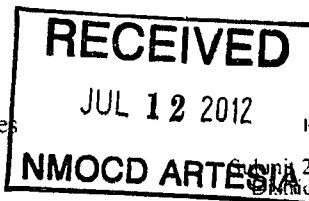

Describe Cause of Problem and Remedial Action Taken.*

A failed gasket on separator allowed for the release of fluid inside the lined facility. The gasket has been replaced on the separator.

Describe Area Affected and Cleanup Action Taken.*

Initially 100bbls of fluid were released from the separator and we were able to recover 98bbls with a vacuum truck. All free fluid from the release was picked up from inside the lined facility. We have removed contaminated gravel and replaced with fresh gravel. The facility has been returned to its prior condition.

Battery is lined with 40 mil plastic. The separator has been removed from service and the gasket is being replaced. We will get more details and follow up with a C-141.
