Pursuant to Division Rule 19.15.15.13, Apache Corporation ("Apache") respectfully requests administrative approval of an unorthodox oil well location for its proposed D State No. 90. This well will be drilled as a development oil well in the Artesia Glorieta-Yeso Pool (96830).

The proposed D State No. 90 will be dedicated to an existing standard 40-acre oil spacing and proration unit in the Artesia Glorieta-Yeso Pool comprising the NE/4 SE/4 of Section 34. This unit is currently dedicated to Apache's: i) existing D State No. 19 (API No. 30-015-31389) located at a standard well location 2310 feet from the South line and 330 feet from the East line; ii) proposed D State No. 89 (API No. 30-015-40234) located at an unorthodox well location 1565 feet from the South line and 990 feet from the East line; and iii) existing Dad State No. 20 (API No. 30-015-32492) located at a standard well location 2310 feet from the East line; and iii) existing Dad State No. 20 (API No. 30-015-32492) located at a standard well location 2310 feet from the East line.

The Artesia Glorieta-Yeso Pool is currently governed by Division Rule 19.19.15.9 which requires standard 40-acre oil spacing and proration units with wells to be located no closer than 330 feet to the outer boundary of the spacing unit.

The attached vicinity map shows that the proposed unorthodox well location is necessary in order to avoid existing pipelines and a road.

The two affected offset tracts are the SE/4 SE/4 of Section 34 and the SW/4 SW/4 of Section 35, Township 17 South, Range 28 East. There is currently no Glorieta-Yeso production in either affected offset tract. The operating rights within the SE/4 SE/4 of

Notice of this application is being provided by certified mail to ConocoPhillips Company, Chaparral Energy, LLC, Chisos, Ltd., Wadi Petroleum, Devon Energy Corporation and Ultramar Oil & Gas Ltd.

Attached is a Form C-102 showing the proposed well, spacing unit and other proposed or existing wells in the spacing unit. Also attached is a map showing the affected offset acreage, vicinity map, and an offset leaseholder notice letter.

In summary, approval of the application will provide Apache Corporation the opportunity to recover additional oil and gas reserves from the Artesia Glorieta-Yeso Pool underlying the NE/4 SE/4 of Section 34 that may otherwise not be recovered by the existing or proposed producing wells, thereby preventing waste, and will not violate correlative rights.






