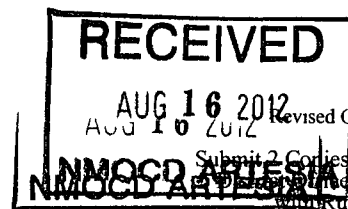

BLM was out doing inspections when the stuffing box leak was found. Fluid was recovered.

Describe Area Affected and Cleanup Action Taken.\*

The leak affected 7,042 sq. ft. of caliche pad, pasture land, and lease road. Impacted soils were removed to a NMOCDA approved disposal facility. Soil samples were collected from the excavations and sent to a commercial laboratory for confirmation of chloride and TPH. The excavations were backfilled with clean caliche and topsoil and contoured to the surrounding area.
