If the analytical results are above the RRAL's a work plan will be submitted.

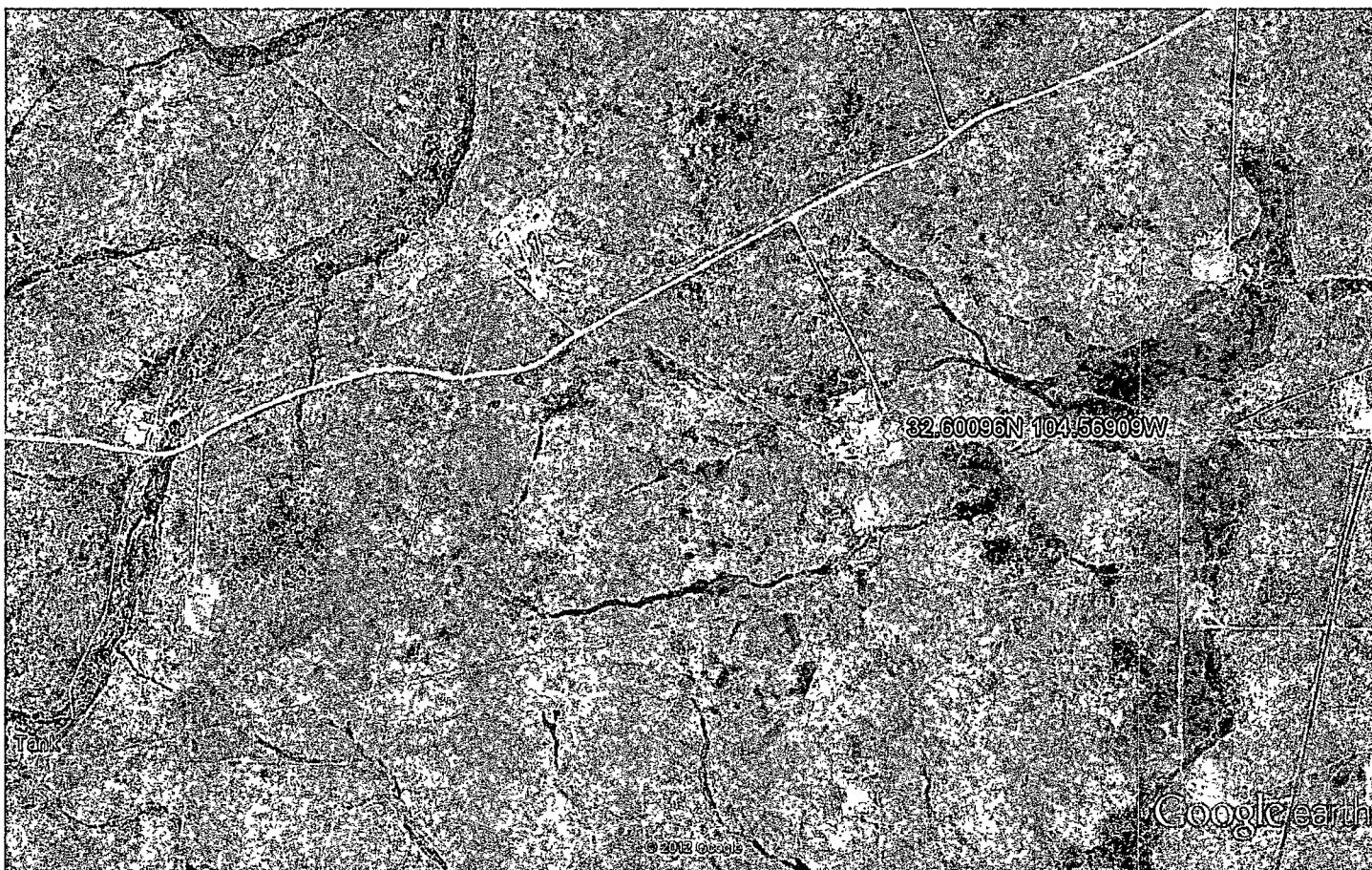
