The valve on the circulating pump was left open which caused 140 bbls of ~~water~~ oil to spill onto the ground. 80 bbls of ~~water~~ oil were recovered via vacuum truck. The valve was closed to prevent further leaking.

Describe Area Affected and Cleanup Action Taken.*

The area affected by the 140 bbls leak is approximately 70' x 40'. Remediation will be performed in accordance with an OCD and BLM approved remediation plan.

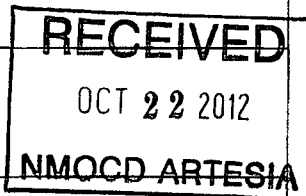

Oxy released 140 bbls of oil due to a 1 INCH VALVE ON CIRCULATING PUMP WAS OPEN. 80 bbls were recovered. The well is located SECT 34 T23S R31E of Eddy County. Oxy will do some initial remediation, a C-141 to follow. BBC International will delineate at a later date.
