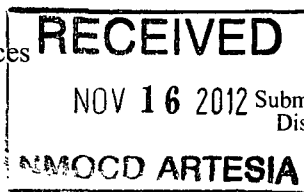

Flow line leak from the pumping unit. Shut down well, shut in valves, crew called to repair line, called vacuum truck. Flow line has been replaced.

Describe Area Affected and Cleanup Action Taken.\*

An approximate area of 20' X 15'. Impacted soils to be scraped up and taken to an NMOCD approved facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX, Chlorides will be run for documentation. If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted.
