
Dear Mr. Lemay:

As attorney-in-fact for Iris Gerber Damson and Trustee of the Edward Trust, I enthusiastically support the application of Merrion Oil & Gas corporation to commingle the Fruitland Coal and the Pictured Cliffs formations in the Blueberry Buckle #1. Enclosed is a copy of the waiver form which I've executed.

The Trust and Mrs. Damson's own overrides in the Pictured Cliffs formation (as well as the Fruitland Coal Formation), in the NW/4 of Section 32. We are concerned that if the commingling is not approved that we will never realize any value for the PC override. Since we have agreed with Merrion to equalize interests in the two formation, we feel that commingling these two zones is in the best interest of all parties involved. Therefore, we request your approval of the application as submitted.
