Well Group No. 2: New Mexico State Wells No. 1 & 2


Allocation of production to each of the wells within each group may be determined on the basis of monthly well tests.

Production shall be stored at a central tank battery located on the State "BL" lease in Section 14, Township 10 South, Range 32 East, NMPM, Lea County, New Mexico.

NOTE: This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations. It is the responsibility of the producer to notify the transporter of this commingling authority.

The operator shall notify the Hobbs district office of the Division prior to implementation of commingling operations.
