As per your request on behalf of Devon Energy Corporation received in this office August 16, 2005, and for the reasons outlined in your letter, a six-month extension of the deadline in which to convert to injection the Todd 13B Federal Well No. 2 (API No. 30-015-28904), approved by Division Order No. SWD-934 is hereby granted.

Provided: The operator shall not begin injection into this well until all pre-conditions contained in the original order are complied with.

The injection authority for this well shall expire on January 22, 2006, if the operator has not commenced injection operations.

Devon Energy Production Company would like to request a 6 month extension of approval, to convert the Todd 13B Fed #2 to water injection. Devon Energy's Form C-108, Application for Authorization to Inject was approved July 22, 2004 (Administrative Order SWD-934). Devon was not able to initiate work to convert the Todd 13B Fed #2 to water injection within the allowed one year approval period, due to work scheduling conflicts. It is anticipated that the salt water disposal conversion will be completed by the end of September 2005.

The well's area of review has been re-checked. Surface and leasehold positions remain the same as reported in the original Form C108 filing. In addition, there have been no wellbores added within the well's area of review.
