THE APPLICATION OF THE OIL CONSERVATION DIVISION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN CHAVES AND EDDY COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This case came on for hearing at 8:15 a.m. on September 2, 2004, at Santa Fe, New Mexico, before Examiner William V. Jones.

NOW, on this 8th day of September, 2004, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner,

FINDS THAT:

(1) Due public notice has been given, and the Division has jurisdiction of this case and its subject matter.

(2) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Abo formation, bearing the designation of East Cottonwood Creek-Abo Gas Pool (Pool Code 97373). The East Cottonwood Creek-Abo Gas Pool was discovered by the Perenco LLC Thames "31" Federal Well No. 1 (API No. 30-015-33139) located in Unit A of Section 31, Township 16 South, Range 25 East, NMPM, which was completed in the Abo formation on March 7, 2004. The top of the perforations is at 5,091 feet.

(3) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Atoka formation, bearing the designation of East Tansill Dam-Atoka Gas Pool (**Pool Code 97372**). The East Tansill Dam-Atoka Gas Pool was discovered by the Mewbourne Oil Company Otis "1" Well No. 2 (API No. 30-015-32888) located in Unit K of Section 1, Township 22 South, Range

27 East, NMPM, which was completed in the Atoka formation on April 9, 2004. The top of the perforations is at 11,166 feet.

(4) There is need for the creation of a new pool in Eddy County, New Mexico for the production of gas from the Mississippian formation, bearing the designation of Walters Lake-Mississippian Gas Pool (Pool Code 97370). The Walters Lake-Mississippian Gas Pool was discovered by the Pecos Production Company Arnold Federal Well No. 1 (API No. 30-015-23988) located in Unit G of Section 34, Township 17 South, Range 30 East, NMPM, which was completed in the Mississippian formation on May 4, 2004. The top of the perforations is at 11,468 feet.

(5) There is need for extensions to the Burton Flat-Morrow Gas Pool, the Cabin Lake-Delaware Pool, the Canyon-Wolfcamp Pool, the South Carlsbad-Morrow Gas Pool, the Happy Valley-Morrow Gas Pool, the North Illinois Camp-Morrow Gas Pool, the Southwest Indian Basin-Morrow Gas Pool, the Ingle Wells-Delaware Pool, the Little Box Canyon-Morrow Gas Pool, the McKittrick Hills-Upper Pennsylvanian Gas Pool, the Northeast Red Lake-Glorieta-Yeso Pool, the Red Lake Shores-Grayburg Pool, the Runyan Ranch-Abo Gas Pool, the Tamano-Bone Spring Pool, the Turkey Track-Atoka Gas Pool, and the White City-Wolfcamp Gas Pool, all in Eddy County, New Mexico; and the North Foor Ranch-Pre-Permian Gas Pool, all in Chaves County, New Mexico.

(c) A new pool in Eddy County, New Mexico classified as a gas pool for Mississippian production is hereby created and designated as the Walters Lake-Mississippian Gas Pool (Pool Code 97370), consisting of the following described area:

(d) The Burton Flat-Morrow Gas Pool (Pool Code 73280) in Eddy County, New Mexico is hereby extended to include:

(v) The White City-Wolfcamp Gas Pool (Pool Code 87285) in Eddy County, New Mexico is hereby extended to include:

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA, 1978, an operator of any well that, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one presently dedicated thereto, shall have 60 days from the effective date of this order to file Form C-102 dedicating a standard unit for the pool to that well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a

standard unit to the well or to obtain a non-standard unit approved by the Division within that 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations and extensions included herein shall be October 1, 2004.
