Marathon Oil Company is seeking permission to surface commingle production on the WM Turner lease. The WM Turner No. 4 is the only original producing well on this lease. Marathon is in the process of adding four additional wells. The WM Turner No. 4 is a downhole commingle Blinbry Oil & Wantz Abo well at the present time, and in addition to the downhole commingled Blinbry & Wantz Abo, Marathon is seeking permission to surface commingle production from three more pools in the common battery facility on the WM Turner lease. The William Turner No. 5 well has shown that it can make more than allowable volumes in the San Andres pool, and that well will be metered independently for oil and gas before being commingled with other battery production.
