THE MATTER OF THE APPLICATION OF RICHARDSON & BASS, A CO-PARTNER-SHIP, FOR APPROVAL OF THE POKER LAKE UNIT AGREEMENT, EMBRACING 68,990.83 ACRES IN EDDY COUNTY, NEW MEXICO, WITHIN TOWNSHIPS 23, 24, 25 AND 26 SOUTH, RANGES 29, 30 AND 31 EAST, NMPM.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 28, 1952, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 1st day of May, 1952, the Commission, a quorum being present, having considered said application and the evidence introduced in support thereof, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the proposed unit plan will in principle tend to promote the conservation of oil and gas and the prevention of waste.

IT IS THEREFORE ORDERED:

SECTION 1. That this order shall be known as the

POKER LAKE UNIT AGREEMENT ORDER

SECTION 2. (a) That the project herein referred to shall be known as the Poker Lake Unit Agreement, and shall hereafter be referred to as the "Project". -2-Case No. 366 Order No. R-153

(b) That the plan by which the Project shall be operated shall be embraced in the form of a unit agreement for the development and operation of the Poker Lake Unit Area referred to in the Petitioner's petition and filed with said petition, and such plan shall be known as the Poker Lake Unit Agreement Plan.

SECTION 3. That the Poker Lake Unit Agreement Plan shall be, and hereby is, approved in principle as a proper conservation measure; provided, however, that notwithstanding any of the provisions contained in said unit agreement this approval shall not be considered as waiving or relinquishing in any manner any rights, duties or obligations which are now, or may hereafter, be vested in the New Mexico Oil Conservation Commission by law relative to the supervision and control of operations for exploration and development of any lands committed to said Poker Lake Unit Agreement, or relative to the production of oil or gas therefrom.

That any party owning rights in the unitized substances who does not commit such rights to said unit agreement before the effective date thereof may thereafter become a party thereto by subscribing to such agreement or counterpart thereof, or by ratifying the same. The unit operator shall file with the Commission within 30 days an original of any such counterpart or ratification.

SECTION 7. That this order shall become effective upon approval of said unit agreement by the Commissioner of Public Lands of the State of New Mexico and the Director of the United States Geological Survey, and shall terminate ipso facto upon the termination of said unit agreement. operator shall immediately notify the Commissioner in writing of such termination.
