The commingled oil production from the wells detailed above shall be measured and sold at the Central Tank Battery located in Unit J of Section 24, Township 12 South, Range 37 East, NMPM, Lea County, New Mexico.


The oil production from the wells shall be continuously measured with allocation meters before commingling with production from other wells. The allocation meters shall be calibrated quarterly. The commingled production from the wells is approved for off-lease measurement and sales.

NOTE: This installation shall be installed and operated in accordance with the applicable Division Rules and Regulations. The producer/Operator shall notify the transporter of this commingling authority.

FURTHER: The operator shall notify the Hobbs district office of the Division prior to implementation of commingling operations.

The provisions of administrative order PC-718 shall continue to be in full force and effect
