That wasn't my email. It was from Jon Bebbington, and is probably the right lat/long. The mistake is on the C-141. Latitude 43 (with Longitude 103) is in South Dakota. Looking at Google, it appears the release was in a small arroyo that is part of several fingers that empty into a larger arroyo. Most of the runoff in this area finds its way into a very large potash mine lagoon to the west. I will touch base with Jon later today.
