Vibration sensor on pump tripped causing pump failure. Alarm system and motor valve failure caused tanks to fill and overflow into containment. Pumps and generator reset. Motor valve closed manually. Vacuum truck dispatched to recover standing fluid. All produced water contained within lined/bermed battery.

Describe Area Affected and Cleanup Action Taken.*
An approximate area of 30' X 100'. All released produced water contained within rhino lined/bermed battery. Liner intact and standing fluid recovered.
Depth to Ground Water: >100' (approximately 120', Section 32-T25S-R29E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on recovered amounts of produced water and release within lined/bermed containment area, Yates Petroleum Corporation requests closure.
