

The ninety in front of the heater treater had a hole in it, spilling oil and water. The well to the facility was shut in, the leak was isolated.

Describe Area Affected and Cleanup Action Taken.*

An approximate area of 40' X 25' (inside an unlined/earthen berm). The leak was isolated. All impacted soils will be taken to a NMOCD approved disposal facility. Vertical and horizontal delineation samples will be taken and analysis ran for TPH & BTEX (chlorides for documentation). If initial analytical results for TPH & BTEX are under RRAL's (site ranking is 10) a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL a work plan will be submitted to the OCD. Depth to Ground Water: 50-99' (95', Section 16, T19S-R25E, NMOSE), Wellhead Protection Area: No, Distance to Surface Water Body: > 1000', SITE RANKING IS 10.
