

There was a fire tube gasket failure on the heater treater inside the facility. The heater treater has been drained and the fire tube has been replaced.

Describe Area Affected and Cleanup Action Taken.*

Initially 10bbbls of produced fluids were released and we were able to recover 8bbbls with a vacuum truck. The release was completely contained inside the lined facility. All free fluid has been recovered and contaminated gravel has been removed. Fresh gravel has been added to the facility as needed. This facility has been returned to its prior condition.
