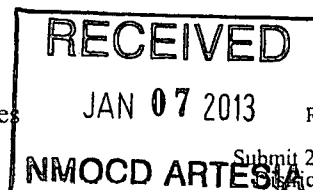

Mobile storage tank overflowed due to increased production from well. Oil from the mobile tank has been pulled to lower the tank level and prevent recurrence.

Describe Area Affected and Cleanup Action Taken.*

Initially 22bbls were released from the tank and we were able to recover 18bbls with a vacuum truck. The release traveled from the tank and streamed off location into the pasture. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a remediation work plan to the NMOC D/BLM for approval prior to any significant remediation work.
