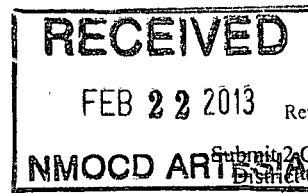

Describe Cause of Problem and Remedial Action Taken.*

The water transport truck appeared to have a clogged filter and screen on his trailer. The truck released fluids on the RESPOSADO 2 STATE #2H location and pasture. The filter and screen have been cleaned and replaced. The trucking company is responsible for the release.

Describe Area Affected and Cleanup Action Taken.*

Initially an estimated 100bbls were released from transfer truck due to clogged filter and screen. We were able to recover 5bbls of fluid with a vacuum truck. The spill area is located on the location and the adjacent pasture. Tetra Tech will sample the spill site area to delineate any possible contamination from the release and we will present a work plan to the NMOC for approval prior to any significant remediation work.
