

If initial analytical results for TPH & BTEX are under RRAL's a Final Report, C-141 will be submitted to the OCD requesting closure. If the analytical results are above the RRAL's a work plan will be submitted. **Depth to Ground Water: 100' (approximately 100', Section 21-T19S-R25E, per Trend Map), Wellhead Protection Area: No, Distance to Surface Water Body: >1000', SITE RANKING IS 0. Based on impacted soils (top 1') excavated/hailed, depth to ground water and enclosed analytical results, Yates Petroleum Corporation requests closure.**
