

Legal Notice

Devon Energy Production Company, LP, 333 West Sheridan Avenue, Oklahoma City, OK 73102-8260 has filed form C-108 (Application for Authorization to Inject) with the New Mexico Oil Conservation Division seeking administrative approval for an injection well. The proposed well, the Burton Flat Deep Unit SWD 1 will be a new drill; proposed location is 330' FSL & 1550' FWL, Section 2, Township 21 South, Range 27 East, in Eddy County, New Mexico. Disposal water will be sourced from area wells producing from the Bone Spring and/or Delaware formations. The disposal water will be injected into the Devonian/Silurian/Ordovician formation at a depth of 12,155' to 14,500'; open hole, at a maximum surface pressure of 2431 psi and a maximum rate of 10,000 BWPD. Any interested party who has an objection to this must give notice in writing to the Oil Conservation Division, 1220 South Saint Francis Drive, Santa Fe, New Mexico 87505, within (15) days of this notice.
