Dear Mr. Jones,

Strata Production Company recently conducted step rate tests on both of the subject wells. Both wells are permitted by the OCD as salt water disposal wells. and well Receives by SW2-3-223. Both wells are currently injecting at the original permitted pressures of .2 psi/ft.

Strata furnished me the resulting data for analysis and presentation. The first test was conducted on the No.6 well on February 4, 2013. Strata personnel believed the test may have been inclusive due to the long duration and slowly applied increases in rate. They performed an additional step rate test on the well two days later. Both test are presented and neither test indicated that formation parting pressure was ever obtained.

Strata Production Company seeks to optimize efficiency, both economically and operationally, of its operations and approval of an increase in surface injection pressures would be in line with that goal. Based on the results of the step rate test, we hereby request that both wells be allowed to inject at pressures of 1650 psi each, keeping the wells set well below what the data indicates and thereby preventing any damage to the formation.




